Stronger Together

Proposition 32:

Newspapers statewide call it 'a fraud ... deceptive ... a sham'

Editors from all over California are agreeing with the League of Women Voters and other good government groups as well as teachers, firefighters and nurses that Proposition 32 is a misleading measure that will make campaign spending worse.

Proposition 32 is cleverly designed to give voters the false impression its authors actually want to restrict money in politics, but the measure has loopholes that allow most businesses, trade groups, insurance trusts, hedge funds and limited liability corporations to continue pouring money into political campaigns. Proposition 32's main financial supporters are multi-millionaires who have previously fought political spending limits, including a shadowy out-of-state group that contributed \$4 million.

Proposition 32 would cripple the ability of Local 1000 and other labor unions from raising money from members to support issues important to state workers, including outsourcing, workplace safety and defending our pensions from future political attacks.

Across the state, more and more newspaper editors and columnists are seeing through the falsehoods of Proposition 32.

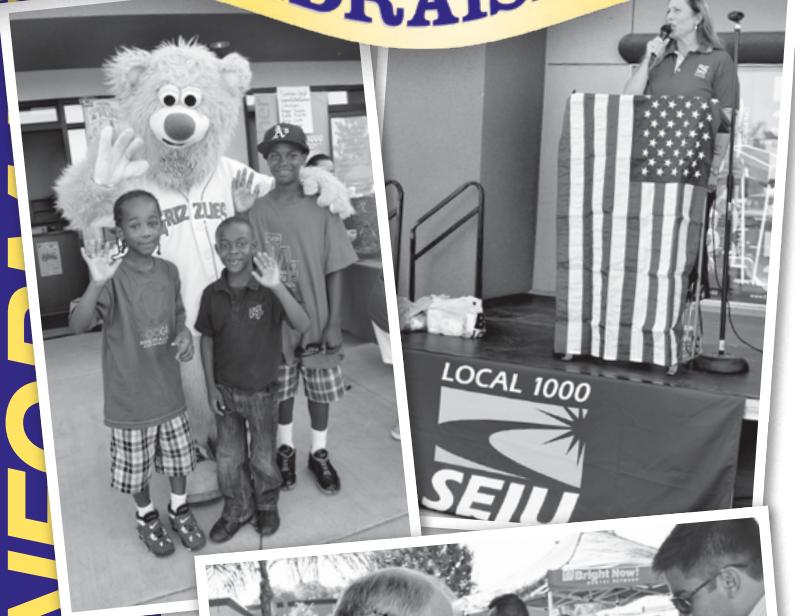
